### **2022 Public Policy Lobby Day**

I believe that the 15 or 16 fair representatives who met with a dozen or so legislators and state officials will agree that our Lobby Day efforts were successful even considering some of the less than positive reactions to our requests.

The \$500,000 for premiums appears to be safely within the Governors budget. A legislative bill to lower the \$5,000 threshold has a reasonable chance of being passed.

Another \$5 million grant is a tough call. Some of us were faced with the pushback that there is still \$15 million not spent by the fairs, "why do you need more money if the fairs haven't spent what they have". This led to a very frank discussion about how difficult it is to get approval from the staff at Ag. & Markets to receive the funds that the Legislature has appropriated for fairs.

I'm not sure if there will be any pressure to bear on Ag & Markets from the Legislature to fix the problem, but I suspect not.

We had a very Positive conversation with Kevin King, Deputy Secretary for Food and Agriculture, from the Governor's office. (Kevin is Pat Hooker's replacement)

It's possible that he will be able to help us, but our first meeting will be with personnel at Ag. & Markets. Somehow, some way we need to get this ongoing problem fixed. There just doesn't seem to be anyone with authority down there that cares about or supports county fairs.

### **We shall keep pushing forward.**

Thank you to Renee St Jacques and staff at Farm Bureau for so much help setting up our meetings with so many influential people. Also thank you to all who participated and helped tell our story.

Every day, there were struggles. Physically, I wasn't sure my body could take it. I lost 10 pounds in one week. But mentally, I struggled. The People came and were so gracious that we were finally giving them something to do but the worry over whether it was enough, were they entertained, was the wait in line too long? Were we going to be able to make these people happy with what we had to offer was taking its toll on me?

I was having trouble finding the joy that had come so easily in the past. I went through the motions; I did my job.

I honestly cannot remember the trigger. It might have been the screaming patron who wanted her money back. It could have been the baby emu that was hurt and had to be evacuated. It could have been standing outside the gate for hours in the hot sun selling tickets, but I found myself needing to take a moment.

So, I went to the baby animal area where the littlest children hang out. And there I found the little girl silently staring into a cage. She appeared to be about three years old.

I got down on my knees and struck up a conversation. She just wanted to touch a bunny. So, I went into the cage and I picked up one of the bunnies and brought it out to her. She was hesitant at first, but I could see with the look on her face that she so desperately wanted to touch the bunny I was holding.

Within a minute, her hand was out and she was petting the bunny in my arms. The smile on her face, the look in her eye was pure, unadulterated joy. As she danced around and squealed with delight, it was in that moment, at least for a little while anyway, I found my joy. I remembered the reason that we put ourselves through this hell every year. For the joy of the children.

The 133rd annual New York State Association of Agricultural Fairs Convention at the Joseph A. Floreano Riverside Convention Center in Rochester, NY was held January 14-17, 2022. Forty (40) Fairs attended as well as many Associate Members of the Association. Over 450 individuals were in attendance. President Jason Lawrence, Chenango County Fair, Norwich, NY welcomed everyone to the Convention.

Keynote speakers included William Stainton, "Connecting the Dots: Breakthrough Thinking for Agriculture Fair Professionals", IAFE presenter Alicia Shoults, Ohio State Fair, "Communicating A Crisis" and Bill Ogg, CFE, Nebraska State Fair, Corndogs & Elephant Ears" sponsored by the Erie County Fair.

A variety of educational sessions continued throughout the four-day event. Speed Series Topics included: "What does it take to prepare your grounds?" What's your Dream and How did you Make it Work? Livestock Show Through a Young Person's Eyes?, Entertainment Tent How does it work?, Rides and Inspections, H2B Labor Issues, Do you have an Emergency Plan, and How to keep Animals and People Safe?, YPI (Young Professionals Initiative), networking, capacity building and recruiting.
